SECTION 4		FIRST AID MEASURES	
First Aid Procedures:	Eyes:	Move victim away from exposure and into fresh air. Flush eyes with plenty of clean water for at least 15 minutes. If symptoms persist, seek medical attention.	
	Skin:	Wash contaminated area thoroughly with mild soap and water. If chemical or solution soaks through clothing, remove clothing and wash contaminated skin. If irritation develops and persists after washing, seek medical attention.	
	Inhaled:	If respiratory symptoms develop, move victim away from source of exposure and into fresh air. If symptoms persist, seek medical attention.	
	Ingestion:	Wash out mouth with water. Remove victim to fresh air and keep at rest in a position comfortable for breathing. If material has been swallowed and the exposed person is conscious, give small quantities of water to drink. Do not induce vomiting unless directed to do so by medical personnel. Get medical attention if symptoms occur.

Extinguishing Media:	Use dry chemical, CO <sub>2</sub> , alcohol-resistant foam or water spray (fog). Use an extinguishing agent suitable for the surrounding fire. Do not use water jet.

Response Techniques:	<p><b><u>Personal precautions, protective equipment and emergency procedures</u></b>  <b>For non-emergency personnel:</b> No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Avoid breathing vapor or mist. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Put on appropriate personal protective equipment. Eliminate all ignition sources.  <b>For emergency responders:</b> If specialized clothing is required to deal with the spillage, take note of any information in Section 8 on suitable and unsuitable materials. See also the information in "For non-emergency personnel".  <b>Environmental precautions:</b> Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air).  <b><u>Methods and materials for containment and cleaning up</u></b>  <b>Small spill:</b> Stop leak if without risk. Move containers from spill area. Dilute with water and mop up if water-soluble. Alternatively, or if water-insoluble, absorb with an inert dry material and place in an appropriate waste disposal container. Dispose of via a licensed waste disposal contractor.  <b>Large spill:</b> Stop leak if without risk. Move containers from spill area. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with noncombustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations. Dispose of via a licensed waste disposal contractor.</p>
SECTION 7	HANDLING AND STORAGE
Handling:	<p><b>Protective measures:</b> Put on appropriate personal protective equipment (see Section 8). Do not ingest. Avoid contact with eyes, skin and clothing. Avoid breathing vapor or mist. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. Empty containers retain product residue and can be hazardous. Do not reuse container.  <b>Advice on general occupation hygiene:</b> Store and use away from heat, sparks, open flame or any other ignition source. Storage:	Store in accordance with local regulations.
